It should give them the opportunity to become creative and innovative.

7.2 Aims

- To be authentic and continue to raise the standards of arts education we offer
- To ensure a positive and inclusive experience for all and an appreciation of different cultures through the arts
- To ensure the arts are exciting, inspiring and engaging
- To provide high quality arts experiences and resources for our students
- To develop effective links with the community
- To celebrate the artistic achievements of each student
- To continue to develop the use of ICT and new technologies in creative work
- To offer students the opportunity to complete the Arts Award at various levels
- To have the opportunity to work as part of a team on an arts project
- To enable students to pass-on their skills to others in creative student-led sessions.

7.3 Objectives

The above aims will be met through the provision of opportunities for all students:

- To actively involve students
- To develop a sense of belonging and ownership by listening to the voice of the students
- To enable personal progression in the arts and with arts-related qualifications
- To continue to develop links with artists and organisations and broaden interests by being introduced to different arts experiences

- To perform and celebrate creative thought and outcome and value every student's contribution to the arts as important
- To use ICT technology and imagination to explore and extend creative thought.
