Introduction



Lifeworks is a Charity. We have services that support children and young people with a learning disability.



This is our **policy** for keeping children and young people safe.

A **policy** explains how things should be done.



Everyone at Lifeworks is responsible for keeping children and young people safe.



We have a separate document which explains what you must do if you think someone is being abused or may come to harm. This is called our Safeguarding Procedure.



Safeguarding

Safeguarding means:

 protecting children from being treated badly



 keeping children and young people healthy and making sure they can grow properly



 making sure children grow up in a safe place, with proper care



 making sure children have the best chances in life.



Child protection

Child protection means doing something to protect a child from harm.

Abuse



There are different types of abuse:

 Physical abuse - this might be hitting, shaking or burning a child or young person.



 Emotional abuse - this might be making a child or young person feel upset on purpose.



 Sexual abuse - this is forcing a child or young person to do something sexual.



 Neglect - this is not giving a child or young person the care they need.

Our policy



Lifeworks will make sure children and young people are safe and have the chance to do well.

Children and young people have the right to be safe.



We won't put up with any kind of harm towards children and young people.



All staff and volunteers will have training about this safeguarding policy.



We will work with families and other organisations to stop any chance of harm towards children and young people.

Who to contact

All new staff will get training in:

 how to do things and how they should work

 how to keep people safe and what to do if someone has been abused or could be harmed

 how to keep records about anything that has happened

 what to do if they are concerned about another member of staff

Staff will be offered training throughout the time that they work with us.

This includes official training about keeping people safe.
