


# What to do if someone is not safe

### Introduction



Lifeworks is a charity that supports people with learning disabilities. Lifeworks supports people of all ages.



This explains what happens if we think that someone is not safe.



Everyone is responsible for keeping people safe.



#### **Vulnerable**

especially **vulnerable** to abuse.

People with a learning disability are



**Vulnerable** means they might come to harm without proper support.

**Abuse** is when someone hurts you or treats you badly.

## If you are worried that someone is not safe



If you are worried that someone is not safe, you should speak to any of the staff.



#### The member of staff:

- will listen to you without interrupting you
- may ask some questions to help you to explain what has happened
- will try to keep things private
- may sometimes have to shareinformation with other people
- tell you that you have done the right thing in speaking up about it
- write down what you said using your words.



The member of staff will report the matter to the **Designated Safeguarding Lead**.

The Designated Safeguarding Lead is a senior manager who is responsible for keeping people safe.



The Designated Safeguarding Lead will tell the Charity Safeguarding Lead and may involve the local council and the police.

### **Telling your family**



### **Small injuries**

If you have small injuries, we may contact your family to discuss the issue.



If the injury is not an accident, we will tell your family that we must tell the local council.



**Neglect or emotional abuse Neglect** means not giving someone the care they need.



**Emotional abuse** means making someone feel upset on purpose.



We will talk to your family about ways that organisations can help.

If the problem does not get better, we will tell the local council about it.



### Sexual abuse

**Sexual abuse** means forcing someone to do something to do with sex when they don't want to.



If we think there may be sexual abuse, we will tell the local council before discussing it with your family.

### **Keeping a record**



If you see something, you must write down what happened. This will be given to the Designated Safeguarding Lead.



Your written note may be passed on to the local council or the police.



Your note will go into a record which we will keep separately from your personal file.



People will only be able to see the record if they need to know.



If you stop receiving services from Lifeworks we may need to tell the service that supports you next that there have been some worries about keeping safe.

### **Serious situations**



If we think that someone has broken the law, we will tell the police as well as the local council.



If we think that someone might be harmed or abused, we will tell the police and the local council.

## If we are asked to share information



We have to share information with the local council and the police if they need it.

We may be asked to provide information for meetings where different professionals talk about keeping you safe.

Usually we will be able to share these reports with your family.

### **Your Protection Plan**



This is where the local council have written a plan which explains how to keep you safe. For adults this is called an Interim Protection Plan and for children it's called a Child Protection plan.



When you have a Protection Plan, we have to tell the local council about:

- any time you are missing from home, if you live at a Lifeworks Service, or if you are missing from school or college
- any changes to the way you behave
- any worries about you.

# If you tell us that a member of staff is abusing you



If you tell us that a member of staff is abusing you we will take immediate action and also tell the local council - depending on the nature of what you have told us we may need to contact the police and the body that regulates our services.

We will take your information seriously and take immediate action to keep you safe.



The local council will ask its safeguarding children or adult's team to support us in the process. They will:

arrange meetings with us



 set up a meeting with senior people in the council and our senior managers



• look into our responses and actions



### We may:

- suspend the member of staff this means they will not come into work
- give the member of staff a warning



Take disciplinary action



If they are not suspended or dismissed we will look at how we can make sure everyone is safe.



We will tell you what has happened in the meetings and what else has been done.



You will be able to have someone with you when you talk to us about these things.


